


**Decision of the Authority in the Matter of Adjustment in Insurance Component of Capacity Charge Part of Tariff of Saif Power Limited (SPL)**

Pursuant to the decision of the Authority dated 20<sup>th</sup> June 2011 in the matter of adjustment at commercial operation date, on the basis of information provided by SPL, the insurance component of capacity charge part of tariff of SPL has been revised on the basis of actual insurance premium of Rs. 156,292,384/- net of F.E.D of 16% as further reduced by Rs. 21,352,723/- on account of F.E.D pertaining to the insurance coverage period 30<sup>th</sup> April-2011 to 29<sup>th</sup> April 2012 in accordance with the Schedule VIII of the Power Purchase Agreement (PPA). The revised insurance component of capacity charge part of tariff indicated hereunder shall be immediately applicable:






