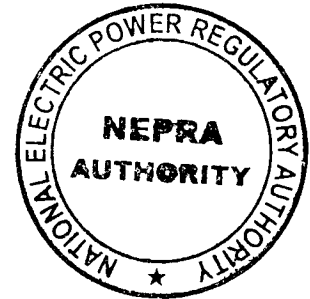


**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR
SAIF POWER LIMITED**

Pursuant to the Paragraph 23(iii)(c) of the Authority's decision dated June 20, 2011 in the case of Saif Power Limited (hereinafter "SPL"), the fuel portion of energy charge part of tariff of SPL has been adjusted for variation in Gas prices. The revised energy charge part of SPL's tariff relating to fuel indicated hereunder shall be immediately applicable on units delivered basis:




