
Dear Sir,


Decision of the Authority in the Matter of Adjustment in Insurance Component of Capacity Charge Part of Tariff of Saif Power Limited (SPL)


Pursuant to the decision of the Authority dated 20th June 2011 in the matter of adjustment at commercial operation date, on the basis of information provided by SPL, the insurance component of capacity charge part of tariff of SPL has been revised on the basis of actual insurance premium of Rs. 171,959,505/-(exclusive of GST) pertaining to the insurance coverage period 30th April-2014 to 29th April 2015 in accordance with the Schedule VIII of the Power Purchase Agreement (PPA). The revised insurance component of capacity charge part of tariff indicated hereunder shall be immediately applicable:





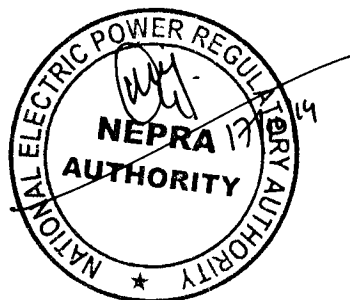
