# DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT BASED ON RLNG FOR SAIF POWER LIMITED

- 1. Pursuant to the decision of the Authority dated June 20, 2011 and May 3, 2016 in the matter of Fuel Price Adjustment (FCA), the fuel portion of energy charge part of the tariff of Saif Power Limited (hereinafter "SPL") has been adjusted for variation in RLNG price.
- 2. Oil & Gas Regulatory Authority (OGRA) vide its determination dated September 16, 2016 has determined Provisional RLNG price for the month August 2016.
- 3. Based on OGRA's Provisional RLNG price determination, the Authority has worked out the Fuel Cost Component of SPL, indicated hereunder, which shall be immediately applicable on units delivered basis:
