





**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT BASED ON
RLNG FOR SAIF POWER LIMITED**


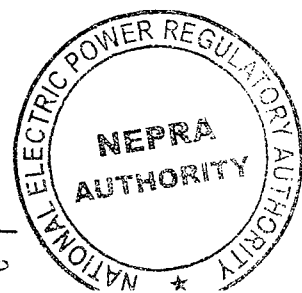
1. Pursuant to the decision of the Authority dated June 20, 2011 and May 3, 2016 in the matter of Fuel Price Adjustment (FPA), the fuel portion of energy charge part of the tariff of Saif Power Limited (hereinafter "SPL") is required to be adjusted for variation in fuel price.
2. Oil & Gas Regulatory Authority (OGRA) vide its decision dated June 5, 2020 has determined provisional RLNG weighted average price for SNGPL for the month of June 2020. Based on OGRA's notification, the fuel cost components on RLNG of SPL have been revised. The revision has been made on provisional basis and final fuel cost components shall be made after notification of final RLNG price by OGRA and submission of fuel invoice(s) by SPL.
3. The revised fuel cost components for the period of June 2020 are indicated hereunder and shall be immediately applicable on unit delivered basis:

Period	Revised Fuel Cost Component (Rs/kWh)
W.e.f. June 1, 2020	6.6730
W.e.f. June 8, 2020	6.7244
W.e.f. June 15, 2020	6.8183
W.e.f. June 22, 2020	6.8183

4. In case RLNG price is not changed or not determined by the OGRA for the next period/month, Fuel Cost Component effective from June 22, 2020 shall remain applicable.
5. The above referred revised fuel cost component of energy charge part of tariff attached as **Annex-I** is to be notified in the official gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
6. CPPA(G) to ensure that all payments are consistent with tariff determinations.
