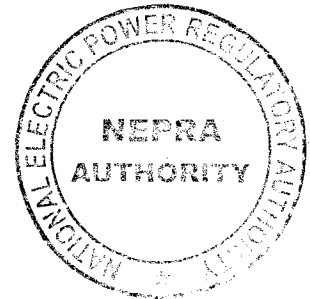


**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR
SAPPHIRE ELECTRIC COMPANY LIMITED**

Pursuant to the Paragraph 11(III)(c) of the Authority's decision dated 21st September 2011 in the case No. NEPRA/TRF-125/SECL-2009 regarding Sapphire Electric Company Limited (hereinafter "SECL"), based on information submitted by SECL, the fuel portion of energy charge part of tariff of SECL has been adjusted for variation in HSD prices. The revised energy charge part of SECL's tariff relating to fuel indicated hereunder shall be immediately applicable on units delivered basis:

For the stock purchased w.e.f. 22 nd October 2012	20.2786


