
**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR
SAPPHIRE ELECTRIC COMPANY LIMITED**



For the stock purchased w.e.f. 1 st May 2013	18.9863



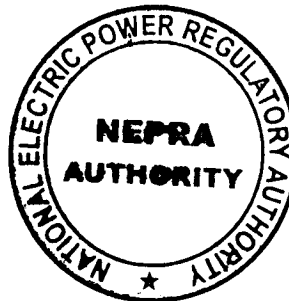


