

SAPPHIRE ELECTRIC COMPANY LIMITED**

Pursuant to the Paragraph 7(III)(c) of the Authority's decision dated 23rd November 2012 in the case No. NEPRA/TRF-125/SECL-2009 regarding Sapphire Electric Company Limited (hereinafter "SECL"), based on information submitted by SECL, the fuel portion of energy charge part of tariff of SECL has been adjusted for variation in HSD prices. 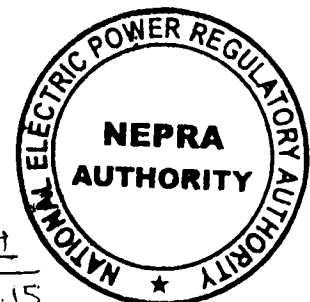
