DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT BASED ON RLNG FOR SAPPHIRE ELECTRIC COMPANY LIMITED

- 1. Pursuant to the decision of the Authority dated 21st September 2011 and 3rd May 2016 in the matter of Fuel Price Adjustment (FCA), the fuel portion of energy charge part of tariff of Sapphire Electric Company Limited (hereinafter "SECL") is required to be adjusted for variation in RLNG price.
- 2. Oil & Gas Regulatory Authority (OGRA) vide its determination dated August 7, 2017 has determined final RLNG price for the month of April 2017. Based on OGRA's final RLNG price determination, SECL requested for revision of fuel cost component for the period of April 2017 and accordingly the fuel cost component has been revised. The revised fuel cost component on final RLNG price, indicated hereunder, shall be immediately applicable on units delivered basis:
