## DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT BASED ON RLNG FOR SAPPHIRE ELECTRIC COMPANY LIMITED

- 1. Pursuant to Decision of the Authority dated September 21, 2011 and May 3, 2016 in the case of Sapphire Electric Company Limited (hereinafter "SECL"), the fuel portion of energy charge part of tariff of SECL has been adjusted for variation in fuel price.
- 2. Oil & Gas Regulatory Authority (hereinafter "OGRA") vide its decision dated January 3, 2018 has determined provisional RLNG price for the Pakistan LNG Limited (hereinafter "PLL") under Petroleum Products (Petroleum Levy) Ordinance, 1961 and Petroleum Products (Petroleum Levy) Rules, 1967 for December 2017 and January 2018.
- 3. Based on Provisional RLNG price determination by OGRA for PLL, SECL vide letter No. SECL/NEPRA/2009 dated January 16, 2018 submitted its request for revision of Fuel Cost Component (hereinafter "FCC") for the month of January 2018. Further, SECL submitted Sui Northern Gas Pipelines Limited (hereinafter "SNGPL") letters No. GMB-37(1974) & GMB-37(2190) dated January 24, 2018 & February 9, 2018, respectively, wherein SNGPL invoiced to SECL US\$10.6161/MMBTU for the 3rd & 4th week of January 2018. SNGPL invoiced to SECL, as per the clause 4 of the Interim Agreement for Supply of RLNG dated January 13, 2018.
- 4. Based on OGRA's notification dated January 3, 2018, FCC on RLNG of SECL has been revised. The revision has been made on provisional basis and final FCC shall be made after notification of final RLNG price by OGRA and submission of fuel invoice(s) by SECL. The revised FCC indicated hereunder shall be immediately applicable on unit delivered basis:


