

ELECTRIC COMPANY LIMITED (SECL)**


Pursuant to the Authority's decision dated 21st September 2011 in the matter of tariff adjustment at Commercial Operation Date (COD) notified vide S.R.O 298(I)/2012 dated 19th March 2012 and in the matter of Motion for Leave for Review against the Decision of the Authority at COD dated 23rd November 2012, based on information submitted by SECL, the fuel portion of energy charge part of tariff of SECL has been adjusted for variation in HSD price. The revised energy charge part of SECL's tariff relating to fuel indicated hereunder shall be immediately applicable on units delivered basis:


Period	Revised Fuel Cost Component Rs./kWh
For the stock purchased w.e.f. 1 st August, 2020	18.9038


The above referred revised fuel cost component attached as **Annex-I** is to be notified in the official gazette, in accordance with the provision of Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.


CPPA (G) to ensure that all payments are consistent with the tariff determination.


