

ADJUSTMENT ON HSD FOR SAPPHIRE ELECTRIC COMPANY LIMITED (SECL)**


Pursuant to the Authority's decision dated September 21, 2011 in the matter of tariff adjustment at Commercial Operation Date (COD) notified vide S.R.O 298(I)/2012 dated March 19, 2012 and in the matter of Motion for Leave for Review against the Decision of the Authority at COD dated November 23, 2012, based on information submitted by SECL, the fuel portion of energy charge part of tariff of SECL has been adjusted for variation in HSD price(s). The revised energy charge part of SECL's tariff relating to fuel indicated hereunder shall be immediately applicable on units delivered basis:

For the stock purchased w.e.f. November 1, 2021	14.6399	27.7315





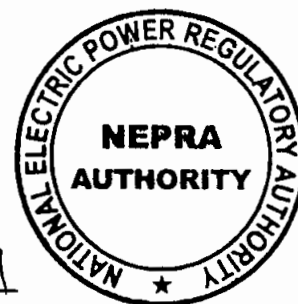
