



**REVISION IN DECISION OF THE AUTHORITY DATED APRIL 02, 2021 IN THE

PROCEDURE) REGULATIONS, 2009**

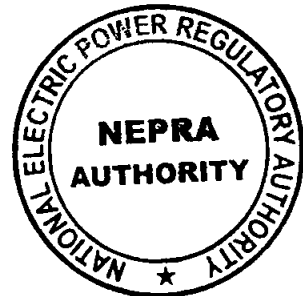

 - Figure 0.1674 appearing in Row 3, Column 2 in Tables under Para 6.3 & Para 7(I) may be replaced with figure 0.0632.


