## DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ADJUSTMENT OF TARIFF FOR SAPPHIRE ELECTRIC COMPANY LIMITED (SECL)

Pursuant to the Paragraph 12(III) of the Authority's decision dated September 17, 2009 in the case of Sapphire Electric Company Limited (hereinafter "SECL"), the tariff of SECL has been revised on account of US CPI, WPI (Manufactures) Local and Exchange Rate variations in accordance with the requisite indexation/adjustment mechanism stipulated in the decision of the Authority. The revised tariff indicated hereunder shall be immediately applicable to the units delivered, post COD, during the quarter October-December 2010:
