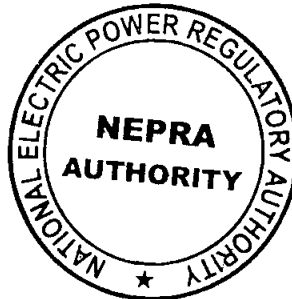

1.	With Effect From 1 <sup>st</sup> January 2010	2.4538



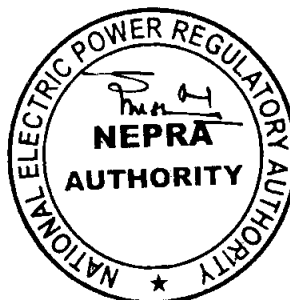
