


**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR
SINDH NOORLABAD POWER COMPANY (PVT) LIMITED**


Pursuant to the Authority's decision dated 4th August 2017 notified vide S.R.O No. 26(I)/2018 dated January 5, 2018 in the matter of Motion for Leave for Review, the fuel portion of energy charge part of tariff of Sindh Nooriabad Power Company (Private) Limited (hereinafter "SNPCL) has been adjusted for variation in gas price. Oil and Gas Regulatory Authority (hereinafter "OGRA") dated October 4, 2018 has notified gas price Rs.629/MMBTU w.e.f. 27th September 2018. Based on OGRA's notification, revised energy charge part of SNPCL's tariff relating to fuel indicated hereunder shall be immediately applicable on units delivered basis:



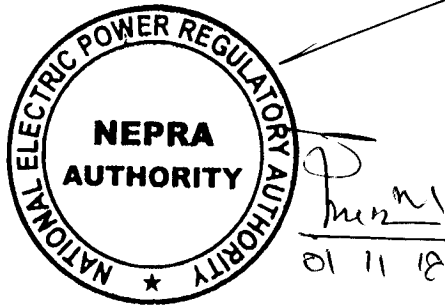

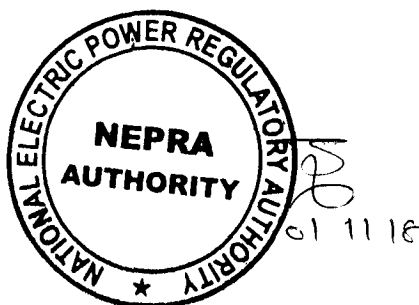
