


DECISION OF THE AUTHORITY IN THE MATTER OF QUARTELY INDEXATION/ADJUSTMENT OF TARIFF FOR SINDH NOORIABAD POWER COMPANY (PRIVATE) LIMITED.


1. Pursuant to the Decision of the Authority dated August 4, 2017 notified vide S.R.O No. 26(I)/2018 dated January 5, 2018 in the matter of Motion for Leave for Review, the tariff of Sindh Nooriabad Power Company (Private) Limited (hereinafter "SNPCL") in respect of July-Sep 2019 quarter has been revised on account of US CPI, CPI (General) and exchange rate variation in accordance with the requisite indexation/adjustment mechanism stipulated in the decision of the Authority. The revised components are indicated hereunder and shall be immediately applicable:




2. Indexation allowed to SNPCL is purely on provisional basis till finalization of its COD tariff by the Authority and shall be subject to adjustment, if necessary, in the light of final decision of the Authority.
3. The revised tariff components attached as **Annex-I** are to be notified in the official gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.
4. K-Electric to ensure that all payments are consistent with tariff determination.

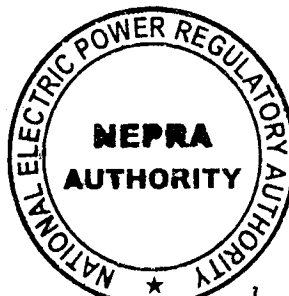


