**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR SINDH
NOORIABAD POWER COMPANY (PVT) LIMITED**


1. Pursuant to the Authority's decision dated 4th August 2017 notified vide S.R.O No. 26(I)/2018 dated January 5, 2018 in the matter of Motion for Leave for Review, the fuel portion of energy charge part of tariff of Sindh Nooriabad Power Company (Private) Limited (hereinafter "SNPCL) has been adjusted for variation in gas price.
2. The Honorable Supreme Court of Pakistan (SCP) in its Judgment dated August 13, 2020 has restrained the Federal Government from charging Gas Infrastructure Development Cess (GIDC) until the amount collected and accrued has not been expended on the projects as listed in the Section 4 of the GIDC Act, 2015.
3. Ministry of Energy (Petroleum Division) vide its letter No. DGO (AC)-8 (49)/20 dated 19th August 2020 directed the concerned entities that the gas bills for the month of August 2020 and onward will not include or reflect GIDC rates and will remain unbilled till further orders. Accordingly, the fuel cost component has been revised on the basis of last notified gas price of Rs.824/MMBTU by OGRA dated June 29, 2019 for IPPs. The revised energy charge part of SNPCL's tariff relating to fuel indicated hereunder shall be immediately applicable on units delivered basis:



5. KE to ensure that all payments are consistent with the tariff determination.

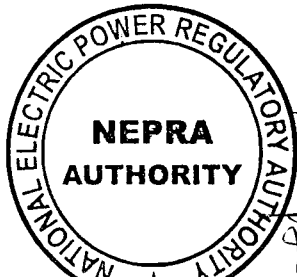


