

**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR  
SINDH NOORIABAD POWER COMPANY (PVT) LIMITED**


1. Pursuant to the Authority's decision dated August 4, 2017 notified vide S.R.O No. 26(I)/2018 dated January 5, 2018 in the matter of Motion for Leave for Review, the fuel portion of energy charge part of tariff of Sindh Nooriabad Power Company (Private) Limited (hereinafter "SNPCL") has been adjusted for variation in gas price.
2. The fuel cost component has been revised on the basis of last notified gas price of Rs.857/MMBTU by OGRA dated October 23, 2020 for IPPs. The revised energy charge part of SNPCL's tariff relating to fuel indicated hereunder shall be immediately applicable on units delivered basis:



4. KE to ensure that all payments are consistent with the tariff determination(s).





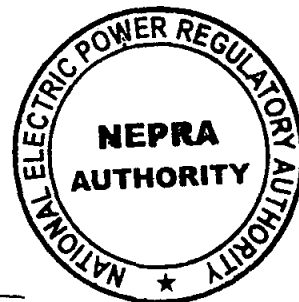
