

**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR
UCH-II POWER PRIVATE LIMITED**

Pursuant to Paragraph VII (a)(iv) of the order of the Authority dated 24th April 2009 in the case of Uch-II Power Private Limited, and the request of Uch-II for variation in the fuel portion of the Energy charge part of Tariff on account of Exchange rate variation for the Quarter ending June 30, 2015 the revised energy charge part of tariff relating to fuel cost component of the Uch-II to the extent of exchange rate variation only has been calculated and indicated hereunder, which shall be immediately applicable on units delivered basis:

Period	Revised Fuel Cost Component Rs./kWh
Quarter ending 30 th June 2015	3.8844

Any variation in gas price as agreed between OGDCL and Uch-II and ratified by Ministry of Petroleum & Natural Resources shall be adjusted accordingly. The above referred revised fuel cost attached as **Annex-I** is to be notified in the official gazette, in accordance with the provisions of Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.

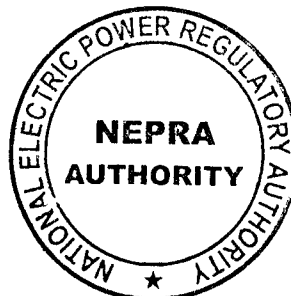

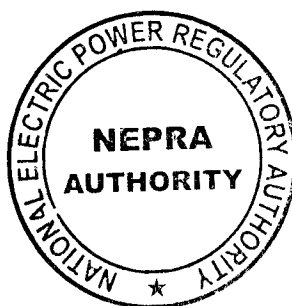
