## DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT OF TARIFF FOR UCH-II POWER PRIVATE LIMITED

Pursuant to the decision of the Authority, in the matter of tariff modification petition filed by Uch-II Pvt. Ltd, issued vide No. NEPRA/R/TRF-266/Uch-II-2014/6209 dated 22<sup>nd</sup> April, 2015 and subsequent corrigendum in the matter issued vide No. NEPRA/R/TRF-266/Uch-II-2014/7053-57 dated May 12, 2015, the fixed and variable O&M cost components of tariff of Uch-II have been revised, for the period from April-June 2014 to April-June 2015 on account of US CPI, WPI (Manufactures) CPI (General) and exchange rate, in accordance with the requisite indexation/adjustment mechanisms stipulated in the above referred decisions of the Authority.
