
**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR  
UCH-II POWER PRIVATE LIMITED**


Pursuant to Paragraph VII (a)(iv) of the order of the Authority dated 24<sup>th</sup> April 2009 in the case of Uch-II Power Private Limited, and the request of Uch-II for variation in the fuel portion of the Energy charge part of Tariff on account of Exchange rate variation for the Quarter ending September 30, 2015 the revised energy charge part of tariff relating to fuel cost component of the Uch-II to the extent of exchange rate variation only has been calculated and indicated hereunder, which shall be immediately applicable on units delivered basis:


Period	Revised Fuel Cost Component Rs./kWh



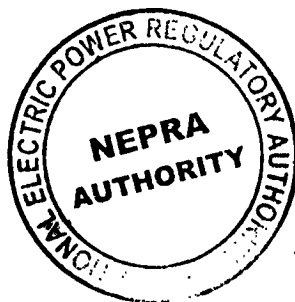
