
Dear Sir,

ADJUSTMENT OF TARIFF FOR UCH-II POWER PRIVATE LIMITED**


Pursuant to the decision of the Authority in the matter of Tariff Modification Petition filed by Uch-II (Private) Limited and Motion for Leave for Review against the Decision of Tariff Modification Petition dated 1<sup>st</sup> October, 2015 read with corrigendum issued on 22<sup>nd</sup> October 2015, the fixed and variable O&M cost components of tariff of Uch-II have been revised for January-March 2016 quarter on account of US CPI, CPI (General) and exchange rate, in accordance with the requisite indexation/adjustment mechanisms stipulated in the above referred decisions of the Authority.


