

UCH-II POWER PRIVATE LIMITED**


Pursuant to the order of the Authority dated 24<sup>th</sup> April 2009 and 1<sup>st</sup> October 2015 read with corrigendum issued on 22<sup>nd</sup> October 2015 in the case of Uch-II Power Private Limited, and the request of Uch-II for variation in the fuel portion of the Energy charge part of Tariff on account of Exchange rate variation and incorporation of GIDC for the Quarter ending December 31, 2016 the revised energy charge part of tariff relating to fuel cost component of Uch-II to the extent of exchange rate variation only has been calculated and indicated hereunder, which shall be immediately applicable on units delivered basis:




The Fuel Cost Component allowed to Uch-II Power Private Limited is purely on provisional basis till finalization of its COD tariff by the Authority and will be subject to adjustment, if any in the light of final decision of the Authority at the time of COD adjustment. Furthermore, any variation in gas price as agreed between OGDCL and Uch-II and ratified by Ministry of Petroleum & Natural Resources shall be adjusted accordingly.




