

**DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/  
ADJUSTMENT OF TARIFF FOR UCH-II POWER PRIVATE LIMITED**

Pursuant to the decision of the Authority dated 22<sup>nd</sup> April 2015 in the matter of Tariff Modification Petition filed by Uch-II (Private) Limited and Motion for Leave for Review against the Decision of Tariff Modification Petition dated 1<sup>st</sup> October, 2015 read with corrigendum issued on 22<sup>nd</sup> October 2015, the fixed and variable O&M cost components of tariff of Uch-II have been revised for April-June 2017 quarter on account of US CPI, CPI (General) and exchange rate, in accordance with the requisite indexation/adjustment mechanisms stipulated in the above referred decisions of the Authority.

The indexation allowed to Uch-II Power Private Limited is purely on provisional basis till finalization of its COD tariff by the Authority and will be subject to adjustment, if any, in the light of final decision of the Authority at the time of COD adjustment.

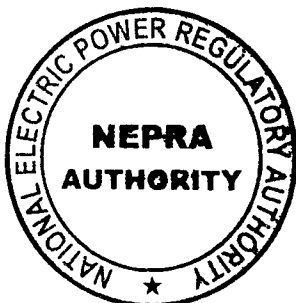
