DECISION OF THE AUTHORITY IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT OF TARIFF FOR UCH-II POWER PRIVATE LIMITED

Pursuant to the decision of the Authority dated 22nd April 2015 in the matter of Tariff Modification Petition filed by Uch-II (Private) Limited and Motion for Leave for Review against the Decision of Tariff Modification Petition dated 1st October, 2015 read with corrigendum issued on 22nd October 2015, the fixed and variable O&M cost components of tariff of Uch-II have been revised for January-March 2017 quarter on account of US CPI, CPI (General) and exchange rate, in accordance with the requisite indexation/adjustment mechanisms stipulated in the above referred decisions of the Authority.


