

**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR
UCH-II POWER PRIVATE LIMITED**

Pursuant to the order of the Authority dated 3rd July 2017 in the matter of tariff adjustment at Commercial Operation Date (COD) of Uch-II Power Private Limited, and the request of Uch-II for variation in the fuel portion of the Energy charge part of Tariff on account of exchange rate variation and incorporation of GIDC for the Quarter ending September 30, 2017, the revised energy charge part of tariff relating to fuel cost component of Uch-II to the extent of exchange rate variation only has been calculated and indicated hereunder, which shall be immediately applicable on units delivered basis:

Period	Revised Fuel Cost Component including GIDC Rs./kWh
Quarter ending 30 th September 2017	4.7904

If any variation in gas price as agreed between OGDCL and Uch-II and ratified by competent Authority shall be adjusted accordingly.

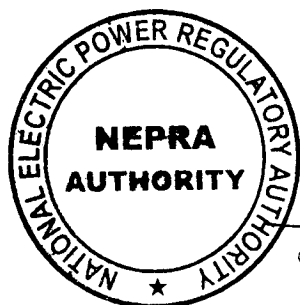

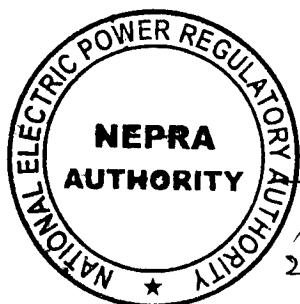
