Pursuant to the decision of the Authority dated 3rd July 2017 in the matter of tariff adjustment at Commercial Operation Date (COD), decision of the Authority dated 24th April 2018 in the matter of Motion for Leave for Review of Uch-II Power Private Limited and the request of Uch-II for adjustment in fuel cost component on account of variation in fuel price due to exchange rate variation and incorporation of GIDC for the Quarter ending June 30, 2019, the revised energy charge part of tariff relating to fuel cost component of Uch-II has been revised. The revised fuel cost component, indicated hereunder, shall be immediately applicable on units delivered basis:
