


**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR  
UCH-II POWER PRIVATE LIMITED**


1. Pursuant to the decision of the Authority dated 3<sup>rd</sup> July 2017 in the matter of tariff adjustment at Commercial Operation Date (COD), decision of the Authority dated 24<sup>th</sup> April 2018 in the matter of Motion for Leave for Review of Uch-II Power Private Limited and the request of Uch-II for adjustment in fuel cost component on account of variation in fuel price due to exchange rate variation and incorporation of GIDC for the Quarter ending September 30, 2019, the revised energy charge part of tariff relating to fuel cost component of Uch-II has been revised. The revised fuel cost component, indicated hereunder, shall be immediately applicable on units delivered basis:


Period	Revised Fuel Cost Component including GIDC Rs./kWh
Quarter ending 30 <sup>th</sup> September 2019	6.4101


2. In case of variation in gas price as agreed between OGDCL and Uch-II and ratified by competent Authority, the fuel cost component shall be adjusted accordingly.
3. The above referred revised fuel cost component attached as **Annex-I** is to be notified in the Official gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
4. CPPA (G) to ensure that all payments are consistent with tariff determinations.

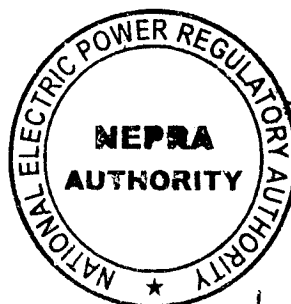



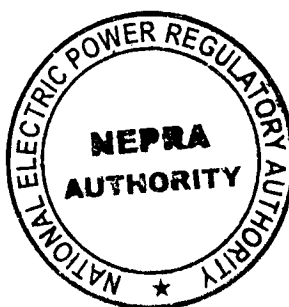
