## DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR THE PERIOD OF JANUARY 2020 TO JUNE 2020 FOR UCH-II POWER PRIVATE LIMITED

- 1. Pursuant to the decision of the Authority dated 3<sup>rd</sup> July 2017 in the matter of tariff adjustment at Commercial Operation Date (COD), decision of the Authority dated 24<sup>th</sup> April 2018 in the matter of Motion for Leave for Review of Uch-II Power Private Limited (hereinafter "Uch-II"), the fuel portion of energy charge part of tariff of Uch-II is required to be adjusted for variation in the fuel price.
- 2. Oil & Gas Regulatory Authority (OGRA) vide its decision dated June 30, 2020 determined and notified the wellhead price of Uch-II natural gas delivered by Oil & Gas Development Company Limited (OGDCL) to Uch-II at US\$ 5.6271/MMBTU for the period from January 1, 2020 to June 30, 2020.
- 3. Based on OGRA's notified gas price and the request of Uch-II for adjustment in fuel cost components due to exchange rate(s) variation, the revised energy charge part of tariff relating to fuel cost components of Uch-II have been approved.
- 4. The revised fuel cost components are indicated hereunder and shall be immediately applicable on units delivered during the respective periods.

- 5. The instant decision shall supercede the decision No. NEPRA/TRF-122/UCH-II-2008/6664-6666 dated February 26, 2020 and decision No. NEPRA/TRF-122/UCH-II-2008/6664-6666 dated April 15, 2020.
- 6. The revised fuel cost components attached as **Annex-I** are to be notified in the Official gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
- 7. CPPA (G) to ensure that all payments are consistent with tariff determinations.
