Please find enclosed herewith the decision of the Authority along with revised tariff components at Annex-I (total 02 pages) regarding quarterly indexation/adjustment of tariff of Uch-II Power (Pvt.) Ltd. for July 1st to September 30st 2023 quarter on account of Energy Charge Part of tariff in Case No. NEPRA/TRF-122/Uch-II-2008.

2. The Decision is being intimated to the Federal Government for the purpose of notification in the official Gazette pursuant to Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 within 30 days from the intimation of this Decision. In the event the Federal Government fails to notify the subject tariff Decision or refer the matter to the Authority for reconsideration, within the time period specified in Section 31(7), then the Authority shall notify the same in the official Gazette pursuant to Section 31(7) of NEPRA Act.

DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR THE PERIOD OF JULY 01ST TO SEPTEMBER 30TH 2023 FOR UCH-II POWER PRIVATE LIMITED

- 1. Pursuant to the decision of the Authority dated July 3, 2017 in the matter of tariff adjustment at Commercial Operation Date (COD), decision of the Authority dated April 24, 2018 in the matter of Motion for Leave for Review of Uch-II Power Private Limited (hereinafter "Uch-II"), the fuel portion of energy charge part of tariff of Uch-II is required to be adjusted for variation in the fuel price.
- Oil & Gas Regulatory Authority (OGRA) vide its decision dated September 21st, 2023 determined and notified the wellhead prices of Uch-II natural gas delivered by Oil & Gas Development Company Limited (OGDCL) to Uch-II for the period from July 01st to December 31st, 2023.
- 3. The Authority in its collective and joint wisdom decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:-

"Based on OGRA's notified gas price and the request of Uch-II for adjustment in fuel cost component due to exchange rate variation, the revised energy charge part of tariff relating to fuel cost component of Uch-II has been revised. The revised fuel cost components are indicated hereunder and shall be immediately applicable on units delivered during the respective period."

- 4. The instant decision shall supersede the decision made on August 8th 2023.
- 5. The revised fuel cost components attached as **Annex-I** are to be notified in the Official gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
- 6. CPPA (G) to ensure that all payments are consistent with tariff determination(s).


