REVISED DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR THE PERIOD OF JULY 1, 2025 TO DECEMBER 31, 2025 FOR UCH-II POWER PRIVATE LIMITED.

- Pursuant to the decision of the Authority dated July 3, 2017 in the matter of tariff adjustment at Commercial Operation Date (COD) and decision of the Authority dated April 24, 2018 in the matter of Motion for Leave for Review of Uch-II Power Private Limited (hereinafter "Uch-II"), the fuel portion of energy charge part of tariff of Uch-II is required to be adjusted for variation in the fuel price.
- 2. Oil & Gas Regulatory Authority (OGRA) vide its decision dated November 5, 2025 determined and notified the wellhead price of Uch-II natural gas delivered by Oil & Gas Development Company Limited (OGDCL) to Uch-II for the period from July 1, 2025 to December 31, 2025. Accordingly, Uch-II vide its letters dated November 11, 2025 requested for revision of fuel cost components on basis of latest notified revised gas price of US\$ 6.1367/MMBTU.
- 3. The Authority in its collective and joint wisdom considering all aspects decided with consensus as under; which will be hereafter called as decision of the Authority in the matter:-

"Based on OGRA's notified gas price and the request of Uch-II for adjustment in fuel cost components due to exchange rates variation, the revised energy charge part of tariff relating to fuel cost components of Uch-II have been revised. The revised fuel cost components are indicated hereunder and shall be immediately applicable on units delivered during the respective period."

- 4. The instant decision shall supersede the decisions made on July 22, 2025 and October 23, 2025 regarding Fuel Price Adjustments for July to September 2025 and October to December 2025, respectively on the basis of last notified available gas price.
- The above decision of the Authority along with revised fuel cost component attached as Annex-I
 are to be notified in the Official Gazette, in accordance with the provisions of Section 31(7) of the
 Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.
- 6. CPPA (G) to ensure that all payments are consistent with tariff determination(s).
