







**CORRIGENDUM REGARDING DECISION OF THE AUTHORITY IN THE MATTER OF  
MOTION FOR LEAVE FOR REVIEW FILED BY UCH-II POWER  
(CASE NO. NEPRA/TRF-122/UCH-II-2008)**


Uch-II Power (Pvt.) Ltd. vide its letter No. 1.16.2/NEPRA/ar dated 6<sup>th</sup> December 2010 pointed out typo error in the Authority's determination dated 26<sup>th</sup> June 2009. Uch-II Power submitted that at Para 10.4 inadvertently 9.1(a)(b)&(c) was mentioned instead of 10.1(a)(b)&(c). Uch-II Power requested for correction of this inadvertent error. Uch-II Power also requested the Authority to issue clarification that all financing terms will be tried up at COD on actual as outlined in the NEPRA determination.


2. The Authority having considered the abovementioned letter is of the view that at Para 10.4 of the determination dated 26<sup>th</sup> June 2009, instead of 10.1(a)(b)&(c) inadvertently 9.1(a)(b)&(c) was mentioned, which is required to be rectified. Accordingly the same is being rectified and inadvertent error at Para 10.4 of the aforementioned determination para 9.1(a)(b)&(c) be read as para 10.1(a)(b)&(c). The Authority further considers that the Para 10.5.2 of its determinations dated 24<sup>th</sup> April 2009 is very clear on the issue of adjustment of financing cost at the time of COD; therefore does not require any further clarification in this regard.


