## DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR **UCH-II POWER PRIVATE LIMITED**

Pursuant to Paragraph VII (a)(iv) of the order of the Authority dated 24th April 2009 in the case of Uch-II Power Private Limited, and the request of Uch-II for variation in the fuel portion of the Energy charge part of Tariff on account of Exchange rate variation only. The Authority considered the request of Uch-II and decided to allow the adjustment in the reference fuel cost component of Uch-II Power (Private) Limited, to the extent of exchange rate variation only. Any variation in gas price as agreed by Uch-II and OGDL shall be adjusted accordingly. Accordingly the revised energy charge part of tariff relating to fuel has been calculated and indicated hereunder, which shall be immediately applicable on units delivered basis:
