## DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR UCH-II POWER PRIVATE LIMITED

Pursuant to Paragraph VII (a)(iv) of the order of the Authority dated 24<sup>th</sup> April 2009 in the case of Uch-II Power Private Limited, and the request of Uch-II for variation in the fuel portion of the Energy charge part of Tariff on account of Exchange rate variation only for the Quarter ending 30<sup>th</sup> June 2014 & 30<sup>th</sup> September 2014, the revised energy charge part of tariff relating to fuel cost component of the Uch-II to the extent of exchange variation only has been calculated and indicated hereunder, which shall be immediately applicable on units delivered basis:

Period	Revised Fuel Cost Component Rs./kWh
Quarter ending 30 <sup>th</sup> June 2014	3.9811
Quarter ending 30th September 2014	3.7702

Any variation in gas price as agreed between OGDL and Uch-II and ratified by Ministry of Petroleum & Natural Resources shall be adjusted accordingly. The above referred revised fuel cost attached as **Annex-I** is to be notified in the official gazette, in accordance with the provisions of Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.


