
**DECISION OF THE AUTHORITY IN THE MATTER OF FUEL PRICE ADJUSTMENT FOR
UCH-II POWER PRIVATE LIMITED**


Pursuant to Paragraph VII (a)(iv) of the order of the Authority dated 24th April 2009 in the case of Uch-II Power Private Limited, and the request of Uch-II for variation in the fuel portion of the Energy charge part of Tariff on account of Exchange rate variation and Gas Infrastructure Development Cess including Federal Excise Duty, for the Quarter ending December 31, 2014 the revised energy charge part of tariff relating to fuel cost component of the Uch-II to the extent of exchange rate variation only has been calculated and indicated hereunder, which shall be immediately applicable on units delivered basis:





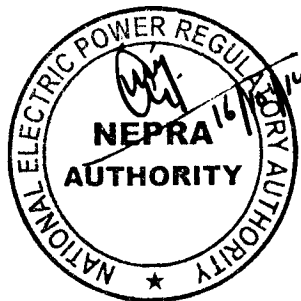
