DECISION OF THE AUTHORITY IN THE MATTER OF QUARTELY ADJUSTMENT/INDEXATION IN THE TARIFF COMPONENTS OF ROE & ROEDC FOR SINDH NOORIABAD POWER COMPANY (PVT) LIMITED FOR QUARTERS JULY TO SEPTEMBER 2023 AND OCTOBER TO DECEMBER 2023

Pursuant to the Authority's decision dated August 4, 2017 notified vide S.R.O No. 26(I)/2018 dated January 5, 2018 in the matter of Motion for Leave for Review and decision of the Authority dated September 21, 2021 notified vide S.R.O. No. 727(I)/2022 on May 31, 2022 in the matter of fuel cost & capacity charge components adjustments on account of approval of capacity and heat rate on June 4, 2021, ROE and ROEDC of Sindh Nooriabad Power Company (Private) Limited (hereinafter "SNPCL") are required to be adjusted on account of Exchange Rate variation.

2. The Authority in its collective and joint wisdom decided with consensus as under; which will be hereafter called as decision of Authority in the matter;


"Indexation/adjustment for July to September 2023 and October to December 2023 quarters have been made in the tariff components of ROE & ROEDC in accordance with the requisite indexation/adjustment mechanism stipulated in the decision(s) of the Authority. The revised components are indicated as **Annex-I** hereunder shall be immediately applicable."

3. Indexation allowed to SNPCL is purely on provisional basis and shall be subject to adjustment/refund, if necessary, in the light of COD tariff true-up decision and pending court case in Islamabad High Court.

4. The revised tariff components attached as **Annex-I** are to be notified in the official gazette, in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.

KE to ensure that all payments are consistent with the tariff determination(s).



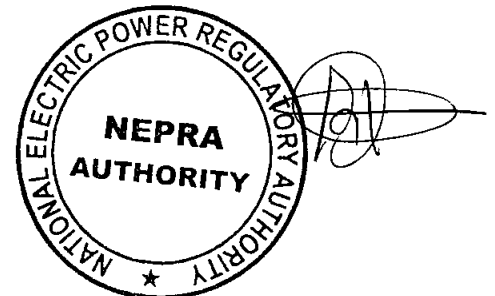
