

DECISION OF THE AUTHORITY IN THE MATTER OF REQUEST FILED BY THE MINISTRY OF ENERGY AND K-ELECTRIC FOR CHANGE IN APPLICABILITY PERIOD REGARDING EARLIER DECISION OF THE AUTHORITY DATED 19.05.2023

1. This is with reference to the decision of the Authority dated May 19, 2023, wherein the Authority approved quarterly tariff adjustment for the consumers of K-Electric @ Rs.1.5547/kWh to be recovered in the months of May, June and July 2023 on the consumption of July, August and September 2022 respectively. The said decision was intimated to the Federal Government for notification.
2. Pursuant to the above decision, K-Electric vide letter dated May 22, 2023 has requested that since billing for the month of May 2023 has already started, therefore, the above quarterly adjustment be allowed to be charged to K-Electric consumers in the month of June, July and August 2023. Similarly, the Ministry of Energy (MoE), vide letter dated May 30, 2023, has also submitted that since the decision was issued late and after due processing/ vetting at various levels, it seems that implementing the said decision during the month of May will be difficult, as billing for the month of May is already at an advance stage and is near completion. The Ministry accordingly also requested to allow the quarterly tariff adjustment to be charged/recovered from KE consumers in the month of June, July and August 2023 on the consumption of July, August and September 2022 respectively.
3. The Authority has accepted the request of K-Electric and the Ministry of Energy and accordingly decides to allow application of Rs.1.5547/kWh on the consumers of K-Electric, in the months of June, July and August 2023, instead of May, June and July 2023, based on consumption of Jul., Aug. & Sep. 2022 respectively. All other contents of the Authority's earlier decision 19.05.2023 would remain same.
4. The decision is intimated to the Federal Government for notification in terms of Section 31 of the Act.




