Tariff Adjustment of KESC due to Variation in Fuel Price and Cost of Power Purchased during the quarter April to June 2006 and O&M CPI Indexation Intimation of Determination of Tariff pursuant to Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act (XL of 1997)

Dear Sir,

Please find enclosed the determination of the Authority along with Annex-I (05 pages) applying the Tariff Adjustment Mechanism specified in Case No. NEPRA/TRF-14/KESC-2002 notified vide SRO 716(I)/2002, dated 12th October 2002.

- 2. Summary of decision is:
 - Adjustment on account of variation in fuel price and cost of power purchased during the quarter April to June 2006 as well as CPI indexation of O&M costs for FY 2006.
- 3. The determination is being intimated to the Federal Government for the purpose of notification of the approved tariff in the official gazette pursuant to Section 31(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act (XL of 1997) and Rule 16(11) of the National Electric Power Regulatory Authority Tariff (Standards and Procedure) Rules, 1998.
- 4. Please note that only Annexure-I to the attached determination containing the schedule of tariff needs to be notified in the official gazette.
- 5. The approval of the tariff is subject to the terms and conditions of schedule of tariff as notified vide SRO 819(I)/2001 dated November 29, 2001 and SRO 325(I)/2002 dated June 11, 2002.

DETERMINATION OF THE AUTHORITY ON TARIFF ADJUSTMENT OF KESC FOR VARIATION IN FUEL PRICE AND COST OF POWER PURCHASE FOR THE QUARTER APRIL TO JUNE 2006

Pursuant to the determination made on September 10, 2002 in Case no. NEPRA/TRF-14/KESC-2002, as notified by the Federal Government vide SRO 716(I)/2002 dated 12th October 2002, the tariff of KESC is subject to adjustment: (a) every three (3) months to compensate for variation in the fuel price and cost of power purchased and (b) every year (in July) for indexation due to CPI (inflation).

- 2. The KESC pursuant to the above mentioned tariff determination has submitted tariff adjustment request vide its communication no. CMF/NEPRA/071/516 dated April 17, 2006. According to the information submitted by KESC, the variation in fuel cost due to fuel price variation and generation mix comes to Rs. 1959 million or Ps. 19.88/kWh, whereas variation in cost of purchase of power works out as 1077 million or paisa 10.93. The combined effect has thus been calculated as Rs. 3,036 Million or paisa 30.81/kWh.
- 3. The examination of the information revealed that KESC had taken into account the gas price increase announced on July 01 2006, whereas as per determination the price of fuel applicable should have been that of June 30th 2006. After making the necessary correction variation in fuel cost due to fuel price and generation mix works out as Rs. 585 million or paisa 5.94/kWh and variation in power purchase cost as Rs.1077 million or paisa 10.93/kWh. The combined effect thus works out as paisa 16.87/kWh.
- 4. KESC had a cumulative leftover balance at the end of March 2006 as Rs. 2990 million on account of variation in fuel price, whereas there was no leftover on account of variation in purchase of power cost. After accounting for the leftover balance, the required increase in the average sale rate of KESC on account of variation in fuel price works out as Ps. 36.28/kWh and on account of purchase of power as Ps. 10.93/kWh. According to the prescribed mechanism, the maximum adjustment that can be allowed in a quarter due to variation in fuel price is 2.5% and due to variation in power purchase price is 1.5% of average sale rate. Therefore, the allowable adjustment on account of variation in fuel price works out as Ps.14.88/kWh and on account of power purchase cost as Ps. 8.93/kWh. The combined effect thus works out as Ps. 23.81/kWh. The cumulative leftover balance after allowing adjustment for the current quarter is Rs. 2109 million for fuel price and Rs. 197.36 million for power purchase which will be adjusted in next quarterly adjustments.
- 5. In order to compensate KESC for variation in fuel cost and power purchase cost, the Authority has decided to allow a uniform increase in consumer-end tariff for all consumer categories by Paisa 24.30 per kWh except for the class of life line consumers consuming up to 50 units per month.

6. The variable O&M costs of KESC have been indexed on the basis of CPI and are due to be adjusted in July 2006..The CPI for the month of March 2006 was 132.97 as notified by Federal Bureau of Statistics whereas for the month of March 2005 the CPI was 124.37 increasing by 6.91%. Consequently the Authority has decided to revise the O&M components as under:

7. The Authority hereby recommends to the Federal Government that the KESC tariff be varied to the extent as indicated in para 5-6 to cater for variation in cost of fuel and power purchase for the quarter April to June 2006 and CPI indexation. For this purpose a new schedule of tariff, annexed to this determination as Annexure-I is hereby intimated for notification, in the official gazette in accordance with the provisions of section 3(4) of the Regulation of Generation, Transmission and Distribution of Electric Power Act (XL of 1997), read with Rule 6 of the NEPRA Tariff Standards and Procedure Rules, 1998.

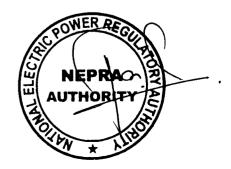
