S.R.O. 368 (I)/ 2011. - In pursuance of sub-section 4 of section 31 of Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997), the Federal Government is pleased to direct that the following amendments shall be made in its Notification No. S.R.O. 144(I)/2009, dated: the 10th February 2009, namely:-


