

CORRIGENDUM – Decision of the Authority in the matter of K-Electric Limited Fuel
charges adjustment for the month of December 2014 issued vide letter No. NEPRA/TRF-
133/KESC-2009/4355-60 dated March 30, 2015 and Notification (S.R.O. 249(1)12015
dated 27.03.2015) thereof

1. The Authority through its subject decision allowed to pass on minus Rs. 1286.691 or minus Ps. 121.203/ kWh, rounded off to minus Ps. 123 / kWh, after not allocating its effect on the consumption of life line and agriculture consumers, on account of variation in fuel cost of K-Electric's own generation as well as power purchased from external sources for the month of December 2014 to be charged by K-Electric in the prospective billing month of April 2015.
2. It has, however, been noted that the weighted average rate of furnace oil (Rs./M.Ton), regarding K-Electric's own generation was inadvertently used as Rs.44,838.71/M.Ton instead of Rs.47,146.36/M.Ton, which resulted in excess reduction of around Rs. 56 Million in fuel price variation on account of own generation.
3. The actual variation on account of changes in fuel cost of K-Electric's own generation as well as power purchased from external sources for the month of December 2014, after making necessary corrections in the weighted average rate of furnace oil, works out to be minus Ps.115.909/ kWh, which rounded off after not allocating its effect on the consumption of life line and agriculture consumers, works out to be minus Ps. 118/kWh and shall be charged by K-Electric according to the following schedule;





 - ii. shall be shown separately in the consumer bills of April 2015 on the basis of units billed for the month of December, 2014.


