

ADJUSTMENT OF TARIFF FOR FPCL POWER COMPANY LIMITED.**


Pursuant to the Decision of the Authority dated May 15, 2017 notified vide S.R.O 1106(I)/2017 dated October 26, 2017 in the matter of Motion for Leave for Review, the tariff of FPCL Power Company Limited (FPCL) in respect of April-June 2018 quarter has been revised on account of US CPI, CPI (General) and exchange rate variation in accordance with the requisite indexation/adjustment mechanism stipulated in the decision of the Authority.
