

**S.R.O. 1491(1)/2022.-** In pursuance of Sub-Section 7 of Section 31 of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 (XL of 1997), NEPRA hereby notifies the decision of the Authority in the matter of reimbursement of 7.5% Withholding Tax on interim Dividend for the Financial Year ended June 30, 2019 in respect of Act Wind Private Limited in Case No. NEPRA/TRF-243/TWEPL-2013.

**DECISION OF THE AUTHORITY IN THE MATTER OF REIMBURSEMENT OF 7.5% WITHHOLDING TAX ON DIVIDENDS FOR ACT WIND (PVT.) LIMITED.**


The Authority issued a decision dated November 21, 2013 in the matter of application of Act Wind (Pvt.) Limited ("AWPL") opting for Upfront Tariff. Subsequently, a revised decision dated May 2, 2014 was issued wherein the financial close deadline for Upfront Tariff was modified. Later, the Authority issued a decision dated January 22, 2016 regarding one-time adjustment of base amount of debt service for USD/PKR parity of the Upfront Tariff for AWPL. Commercial Operations Date (COD) was achieved by AWPL on October 08, 2016.

2. In accordance with the decision(s) referred above, AWPL requested for the reimbursement of Rs. 36,503,419 on account of 7.5% Withholding Tax ("WHT") on interim dividend for the financial year ended June 30, 2019. The Authority has considered the request of AWPL and decided to approve the claimed amount of Rs. 36,503,419 to be reimbursed by the power purchaser to AWPL.

3. The instant decision is to be notified in the official gazette in accordance with the provisions of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act 1997.

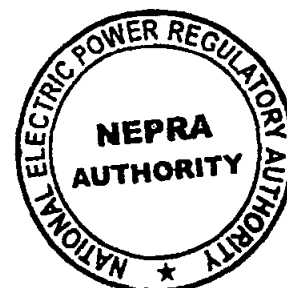
4. CPPA-G to ensure that all the payments are consistent with tariff determination.




