

(formerly Hub Power Company Ltd.-Narowal) under NEPRA (Review Procedure) Regulations, 2009 in Case No. NEPRA/TRF-92/HUBCO-2008.

REVISION IN THE DECISION OF THE AUTHORITY DATED APRIL 27, 2021 IN THE MATTER OF QUARTERLY INDEXATION/ ADJUSTMENT OF TARIFF FOR NAROWAL ENERGY LIMITED (FORMERLY HUB POWER COMPANY LIMITED-NAROWAL) UNDER NEPRA (REVIEW PROCEDURE) REGULATIONS, 2009.

1. Inadvertent errors have been identified in the decision of the Authority and ~~attached~~ Annex-I issued vide letter No. NEPRA/R/ADG(Trf)/TRF-92/HUBCO-2008/21466-21468 dated April 27, 2021 in the matter of quarterly indexation/adjustment of tariff for April-June 2021 quarter in the matter of Narowal Energy Limited, which need to be corrected.
2. In pursuance of Section 7(2)(g) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997 read with Regulation 3 of NEPRA (Review Procedure) Regulations, 2009, the Authority has decided to correct the following errors:
 - The figure of 0.0924 appearing in column 2, row 4 of Tables in the decision and Annex-I may be replaced with 0.0533.
 - The figure of 0.1608 appearing in column 3, row 4 of Tables in the decision and Annex-I may be replaced with 0.0928.
 - The figure of 0.5007 appearing in column 2, row 12 of Tables in the decision and Annex-I may be replaced with 0.2888.
 - The figure of 0.8714 appearing in column 3, row 12 of Tables in the decision and Annex-I may be replaced with 0.5026.
3. The impact of delayed payment charges, if any, shall be adjusted by the power purchaser accordingly.






