

March 28, 2021 to March 27, 2022	73,061,170	0.4766

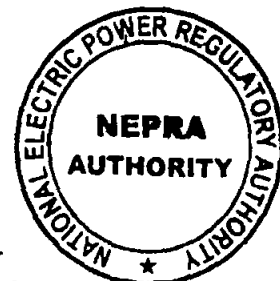
