**Decision of the Authority in the Matter of Adjustment in Insurance Component of Tariff for FFC Energy Limited (FFCEL).**


Pursuant to the decision of the Authority dated November 10, 2014 in the matter of tariff adjustment of FFC Energy Limited (FFCEL) at commercial operation date (COD) and decision of the Authority dated July 31, 2015 in the matter of motion for leave for review filed by FFCEL against COD tariff adjustment decision, the insurance cost and corresponding component of tariff of FFCEL for the period from January 01, 2022 to December 31, 2022 is given as under:

January 01, 2022 to December 31, 2022	54,195,702	0.3775

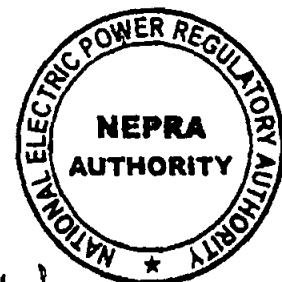
2. The claim of insurance with respect to marine cargo has not been considered as the same is not covered in the scope of insurance as given in EPA. Further the claim of insurance with respect to Motor Car has been restricted to the vehicles being used at the site of the plant.
3. The above tabulated revised insurance component of tariff is to be notified in the official gazette, in accordance with the provision of Section 31(7) of the Regulation of Generation, Transmission and Distribution of Electric Power Act, 1997.
4. CPPA-G to ensure that all the payments are consistent with tariff determination.


