

November 22, 2019 to November 21, 2020	36,927,490	0.2422



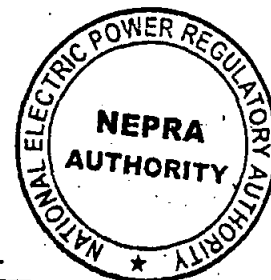
3. CPPA-G to ensure that all the payments are consistent with tariff determination.


