

ADJUSTMENT THE **MATTER** OF OF THE **AUTHORITY** INSURANCE COMPONENT OF CAPACITY CHARGE PART OF TARIFF OF SAIF POWER LIMITED.

1. Pursuant to the decision of the Authority dated June 20, 2011 in the matter of adjustment at Commercial Operation Date (COD) in the case of Saif Power Limited (SPL), the insurance component of tariff is subject to adjustment as per actual annually. SPL vide its letter dated July 7, 2022 requested to approve insurance component of Rs. 0.1357/kW/Hour for the period April 30, 2022 to April 29, 2023. SPL also submitted copies of insurance policies, premium calculations and payment evidences. The details of requested insurance cost net of Sales tax on Services is as under:

Accordingly, on the basis of documents provided by SPL, Schedule VIII of PPA and insurance premium of Rs. 249,219,736/-(exclusive of Sales tax on Services), the insurance component of capacity charge part of tariff has been revised pertaining to coverage period April 30, 2022 to April 29, 2023. The revised insurance component of capacity charge part of tariff indicated hereunder shall be immediately applicable:
