<u>DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN</u> <u>INSURANCE COMPONENT OF TARIFF FOR NISHAT CHUNIAN POWER LIMITED</u>

 Pursuant to the decision of the Authority dated December 31, 2010 in the matter of adjustment at Commercial Operation Date (COD) in the case of Nishat Chunian Power Limited (NCPL), the insurance component of tariff is subject to adjustment as per actual annually. NCPL vide its letter dated August 11, 2021 requested to approve insurance component of Rs. 0.1323/kW/h for the period July 1, 2021 to June 30, 2022. NCPL in support of its request submitted copies of insurance policies, premium calculations, no claim bonus and payment evidences of previous year. The details of requested insurance cost net of Federal Excise Duty/Sales Tax on Services is as under:
