DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE COMPONENT OF CAPACITY CHARGE PART OF TARIFF FOR NISHAT POWER LIMITED

Pursuant to the decision of the Authority dated March 22, 2011 in the matter of Motion for Leave for Review filed by NPL against the decision of the Authority at COD dated October 15, 2010 regarding Nishat Power Limited (NPL), the insurance component of tariff is subject to adjustment as per actual annually. NPL vide its letter No. Ins/NPL/0821-16189 dated August 12, 2021 requested to approve insurance component of Rs. 0.1674/kW/h for the period July 1, 2021 to June 30, 2022. NPL in support of its request provided copies of insurance policies, premium calculations, endorsement notes. NPL further vide dated October 9, 2021 provided payment evidences of previous year and detail of no claim bonus. The details of requested insurance cost net of sales tax on services is as under:

- 2. Schedule VIII of PPA does not provide for hospitalization, head office and cash insurances, therefore, the same have not been considered. Further, Schedule VIII of PPA does not provide for marine insurance during operational phase of the project, therefore, the same has also not been considered.
- 3. Accordingly, on the basis of documents provided by NPL, Schedule VIII of PPA and remaining insurance premium of Rs. 279,959,600/- (exclusive of sales tax on services), the insurance component of capacity charge part of tariff has been revised pertaining to coverage period July 1, 2021 to June 30, 2022.. The revised insurance component of capacity charge part of tariff as indicated hereunder shall be immediately applicable:
